FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, on September 8, 2008, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Lewis Carl Smith, III, and Delhi Insurance Group, LLC ("Respondents") a certified letter requesting a response to a consumer complaint and a list of company appointments.

WHEREAS, on October 14, 2008, certified mail article # 7004 1160 0000 3843 2029, addressed to Delhi Insurance Group, LLC was delivered by the US Postal Service to the Respondent and was signed for by Respondent, Lewis Carl Smith, III.

WHEREAS, Respondents have failed to provide a list of appointments within ten (10) days as requested by the Commissioner.

WHEREAS, Respondents' failure to provide said list constitutes a violation of IC 27-1-15.6-12(g).


WHEREAS, the Commissioner has the authority to issue an order suspending Respondents' licenses without a hearing pending receipt of said list of appointments pursuant to IC 27-1-15.6-12(g).

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondents pursuant to IC 4-21.5-4-4.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent Smith's license number 466287 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent Delhi Insurance Group, LLC's license number 36344 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
