WHEREAS, Respondent is a licensed resident insurance agent in the State of Indiana, operating under License Number 406160, and


WHEREAS, the parties conversed prior to an administrative hearing for the purpose of negotiating a settlement of the issues relating to the Respondent's Producer License; and

IT IS THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives his right to a public hearing on the issues relating to his Indiana Producer License.
4. Respondent voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent's conduct violated Indiana Code § 27-1-15.6-12(b)(8).
6. Respondent agrees to the permanent revocation of his Indiana Producer License.
7. Respondent has carefully read and examined this agreement and fully understands its terms.
