ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code section 4-21.5-1 *et seq.*, hereby gives notice to Jeanette Desruisseaux (“Respondent”), of the following Administrative Order:

1. Indiana Code section 27-1-15.6-12(b) provides that “[t]he commissioner may . . . refuse to issue or renew an insurance producer license . . . for . . . [f]ailing to timely inform the commissioner of a change in legal name or address, in violation of section 7(h) of this chapter.”

2. Indiana Code section 27-1-15.6-7(h) provides that “[a] licensee shall inform the commissioner of a change of address not more than thirty (30) days after the change by any means acceptable to the commissioner.”

3. Indiana Code section 27-1-15.6-12(d) provides that when the commissioner refuses to renew a license, the commissioner shall notify the Respondent, in writing, of the reasons for the nonrenewal.

4. Respondent holds active non resident license number 598556 which is set to renew on May 31, 2010.

5. On June 3, 2009, the Department received notice of Respondent's termination for cause from GEICO.

6. Upon investigation by the Department, it was determined that Respondent may have acted in a manner that was contrary to law.

7. On September 4, 2009, the Department sent Respondent a request for a list of appointments pursuant to Indiana Code section 27-1-15.6-12(g), and a request for a response to the GEICO termination via certified mail number 7005 3110 0002 4440 2340. This was sent to Respondent's address located in SIRCON.

8. The Department's September 4, 2009, letter was returned as not deliverable on September 17, 2009.

9. On September 21, 2009, the Department searched Accurint, a database utilized by the Department in locating producer's current addresses.

10. On the same day, the Department sent Respondent a second request for a list of appointments and request for a response to the GEICO termination, as well as notification of the change of address violation. Said request was sent via certified mail number 7005 3110 0002 4440 0926 to the most recent address listed in the Accurint report.

11. The Department's September 21, 2009, letter was returned as vacant on October 19, 2009.

12. Without a proper address, the Department is unable to exercise its regulatory authority over Respondent.

13. Respondent's conduct, as alleged herein, is cause for disciplinary action in accordance with Indiana Code section 27-1-15.6-12(b).

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies that Respondent's license shall not be renewed.

WHEREFORE, the Commissioner further notifies Respondent that pursuant to Indiana Code section 27-1-15.6-12(d), within sixty (60) days of receiving this Notice, Respondent may make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
