IT IS THEREFORE ORDERED, by the Commissioner of Insurance:

1. Respondent failed to notify the Department of an administrative action taken by the State of Illinois whereby his producer’s license in that state was revoked.
2. The allegations constitute violations of Indiana Code § 27-1-15.6-12(b)(9) and

Indiana Code § 27-1-15.6-17(a).

3. Respondent's producer license 492135 shall be permanently revoked, effective immediately.

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:


1. The Acting Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives the right to a public hearing.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.
5. Respondent agrees to a **Permanent Revocation** of his Indiana insurance license number 492135 as **Permanent Revocation** is defined under Indiana Code 27-1-15.6-12(a)(1) and (2).
6. Respondent has carefully read this agreement and fully understands and accepts its terms.




