




## **Certification Required by Section 1511 of the American Recovery and Reinvestment Act – September submittal**

Pursuant to Title XV, Subtitle A, Section 1511 of the American Recovery and Reinvestment Act (Pub.L. 111-5) (ARRA) enacted on February 17, 2009, I, Jennifer M. Alvey, Public Finance Director of the State of Indiana, hereby certify that the infrastructure investments that may be funded with amounts appropriated by ARRA for the Clean Water State Revolving Fund Loan Program (CWSRF) and the Drinking Water State Revolving Fund Loan Program (DWSRF) described in Exhibit A to this certification letter have received the full review and vetting required by law and that I accept responsibility that such investments are appropriate uses of taxpayer dollars.

I further certify that as the State of Indiana identifies additional projects to which Section 1511 certification would apply, I will cause the Indiana Finance Authority to amend Exhibit A accordingly and I will submit an additional certification letter for each such amendment.

I further certify that the specific information required by Section 1511 concerning each such investment (a description of the investment, the estimated total cost, and the amount of ARRA funds that might be used) is provided on Exhibit A and is available at <http://www.srf.in.gov> and will be reflected on Recovery.gov.

I understand that my State or local agency may not receive ARRA infrastructure investment funding unless this certification is made and posted.
