RE: Waiver of Application of 42 IAC 1-5-1 ("Gift Rule") for Jennifer Walthall, MD, MPH, Secretary for the Family & Social Services Administration and Executive Staff Attending the Covering Kids & Family Annual Meeting and Program Luncheon on December 5, 2017

Dear Mr. Clevenger:

Under the authority designated to me by Indiana Family & Social Services Administration ("FSSA") appointing authority Jennifer Walthall, MD, MPH to waive application of the Gift Rule in individual cases when consistent with the public interest, I waive application of the Gift Rule for Dr. Walthall and the attached list of FSSA employees who attended the Covering Kids & Families of Indiana 15th Annual Meeting and Program Luncheon on December 5, 2017 at the Marriott East located at 7202 East 21 Street, Indianapolis, Indiana. Dr. Walthall received the Governor Frank O'Bannon Memorial Kids First Award in recognition of the breadth of her work over the years including her work at the Indiana State Department of Health, Indiana University School of Medicine, Riley Hospital for Children, and FSSA.

The cost to purchase a ticket was \$50.00. The event included a plated luncheon with awards and speakers. Additionally, Dr. Walthall, received an award in the form of a piece of artwork valued at \$300.00. To comply with the gift rule, Dr. Walthall will give the artwork she received to FSSA and it will be displayed it in a common area.

Covering Kids & Families of Indiana is an organization that informs statewide policymakers and advocates on behalf of its coalitions and consumers regarding polices to improve healthcare access, retention and outcomes. FSSA has had a business relationship with Covering Kids & Families of Indiana in the past; however, FSSA does not currently have a business relationship with the organization. The event was sponsored by the following entities with whom FSSA currently has a business relationship: Anthem BlueCross BlueShield, CareSource, Community Health Network, Health and Hospital Corporation, MDwise, and United Healthcare. Additional sponsors include Health Management Associates and Indiana Primary Health Care Association

with whom FSSA has had previous business relationships. Therefore, FSSA considers the gift rule to be applicable.

Given that the award bestowed upon Dr. Walthall was in honor of the late Governor Frank O'Bannon's efforts to promote the wellbeing of Indiana children, which is consistent with FSSA's mission and that the artwork will be displayed in a common area, I believe that granting a waiver from the gift rule is consistent with the public interest.
