RE: Waiver of Application of 42 IAC 1-5-1 ("Gift Rule") for Family and Social Services Administration, Division of Aging Employees Victoria Sovern and Sherry Beck

Dear Mr. Clevenger:

Under the authority designated to me by Indiana Family & Social Services Administration ("FSSA") appointing authority Jennifer Walthall, MD, MPH to waive application of the Gift Rule in individual cases when consistent with the public interest, I waive application of the Gift Rule for Victoria Sovern and Sherry Beck so they may attend the 2017 WINGS Retreat sponsored by the Supreme Court-Adult Guardianship Office, WINGS Indiana Adult Guardianship State Task Force, Indiana Association of Area Agencies on Aging ("IAAAA") and Indiana Professional Management Group ("IPMG") November 8 - 9, 2017 in Indianapolis, IN and accept free materials and meals.

The WINGS Indiana Adult Guardianship State Task Force is a voluntary workgroup focused on the improvement of adult guardianship services across the state. FSSA does not have a business relationship with the task force. IMPG is a case management company that provides services to individuals participating the Home and Community-Based Services Medicaid Program administered by FSSA. FSSA has a direct business relationship with IMPG and with the 15 Area Agencies on Aging ("AAA") that compromise IAAAA. The AAAs have grants and contracts with FSSA to deliver services to older adults and individuals with disabilities. Since FSSA has business relationships with IMPG and the AAAs that compromise IAAAA, FSSA considers the gift rule to be applicable

The items of value to be received are materials and three meals, two lunches and a dinner. Attached is a copy of the announcement flyer and agenda.

The main goal of the retreat is to develop a comprehensive plan that addresses the needs of individuals that require the protection and support of guardianship or other less restrictive

alternative support services. This is the same population the FSSA Division of Aging, Adult Protective Services is responsible for serving. It is in the best interest of the public that as Ms. Sovern as State Director of Adult Protective Services and Ms. Beck as Assistant Director of Adult Protective Services attend to represent the agency's position.

Therefore, I am granting the waiver sought by Mses. Sovern and Beck because it is consistent with the public interest for Mses. Sovern and Beck to attend this free retreat and accept materials and meals so that she may learn from other attendees and contribute to the discussion of how to improve the quality of and access to adult guardianship services for individuals receiving services from FSSA.


