

RESOLUTION 2001-6

A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIERS' LICENSES

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

1. On January 27, 2000, by RESOLUTION 2000-3, a permanent supplier's license was issued to Midwest Game Supply Co.
2. On March 30, 2000, by RESOLUTION 2000-10, a permanent supplier's license was issued to Dallmann Systems, Inc.
3. On March 30, 2000, by RESOLUTION 2000-11, the renewal of suppliers' licenses was issued to AC Coin, GAMECASH, Inc., Anchor Coin Inc., Lodging and Gaming Systems, Inc. and WMS Gaming, Inc.
4. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a supplier's license must be renewed annually.
5. The above-named supplier licensees have requested a renewal of licensure. The renewal will be conditioned upon payment of the renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. If payment of the renewal fee is not received as directed by Commission staff, the licenses will be subject to revocation.
6. The Commission has determined that the above-named supplier licensees remain in compliance with IC 4-33.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to all supplier licensees listed above in paragraph one, two and three.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. GRANT OF RENEWAL OF SUPPLIERS' LICENSES.

The Commission hereby grants the renewal of the suppliers' licenses issued to the suppliers listed below on condition that the renewal fee is paid as directed by the Commission staff. The renewed suppliers' licenses will be valid for a period of one (1) year from the date of issuance.

SECTION 4. CONDITIONS PLACED ON SUPPLIER'S LICENSE.

- A. Each supplier licensee must request renewal of licensure at least thirty (30) days before the expiration of the license in accordance with 68 IAC 2-2-8.

SECTION 5. EFFECTIVE DATE.

This RESOLUTION is effective immediately.
