

**ORDER 2010-11**  
**AN ORDER OF THE INDIANA GAMING COMMISSION**  
**CONCERNING THE VOLUNTARY EXCLUSION PROGRAM**  
**CASE NO. VEP-10-10**

On or about January 1, 2008, John Doe #10 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program for a minimum of one year. Pursuant to 68 IAC 6-3-2(d), if a patron does not request removal from the program after the expiration of the program term, he or she remains validly in the program. Pursuant to 68 IAC 6-3-2(g), a participant in the program agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission he or she willingly forfeits any money or thing of value obtained from or owed to the participant by a casino. The casino must withhold forfeited monies or things of value and remit them to the Commission, which collects the funds.

On or about February 4, 2010, John Doe #10 was discovered to be present at Blue Chip Casino ("Blue Chip"). At that time, John Doe #10 had not requested removal from the program. At that time, John Doe #10 had obtained \$25.00 in chips from Blue Chip. Blue Chip withheld the monies as required by Commission regulations and seeks Commission approval for remittance, less applicable taxes on the winnings, in fulfillment of John Doe #10's voluntary exclusion application.

The Commission, after reviewing this matter:


APPROVES

the remittance of \$25.00, less applicable taxes, in fulfillment of John Doe #10's voluntary exclusion application.

Pursuant to IC 4-21.5-3-5, this ORDER becomes effective 15 days following receipt of the Order of the Indiana Gaming Commission.
