Re: HHF Blight Elimination Program (BEP)- Deadline Extension

The IHCDA Asset Preservation Department has obtained authority from the U.S. Department of the Treasury to undertake a statewide Blight Elimination Program using a portion of Indiana’s Hardest Hit Fund allocation. The application packet and supporting documentation are currently available at www.877GetHope.org/blight or www.in.gov/ihcda/2340.htm.

Indiana has been divided in to six funding divisions to facilitate the implementation of the Blight Elimination Program. **The application deadlines for funding divisions one, two and three have been extended.** The award announcement dates for funding divisions one, two and three have been adjusted to facilitate the application deadline extensions. The application deadlines and award announcement dates for funding divisions four, five and six remain unchanged. The chart below contains the funding division, the original application due date, the extended application due date (where applicable) and the revised award announcement date (where applicable).
