The CFA Foundation does not judge who is at fault and it does not affect our decision on who we help. The Foundation awards gifts that are flexible, varied and discretionary. The financial assistance does not impact workers' compensation, insurance or other payments.

How Do We Help?

The Foundation works to provide financial assistance as soon as possible after an incident to bridge the gap until workers' compensation or other insurance is available to the family.

Applications are reviewed by the Client Outreach Committee which works swiftly to address an application as soon as it is received. Several contacts may need to be made during the review process in order to better understand the situation and how the Foundation can best assist. Once vetted, the Client Outreach Committee sends the application to the Board of Directors for approval.

Funds can be used for various items including, but not limited to, mortgage payments, utilities, gasoline, groceries, car payments, counseling, travel expenses, childcare, education, clothing, legal expenses or funeral expenses.

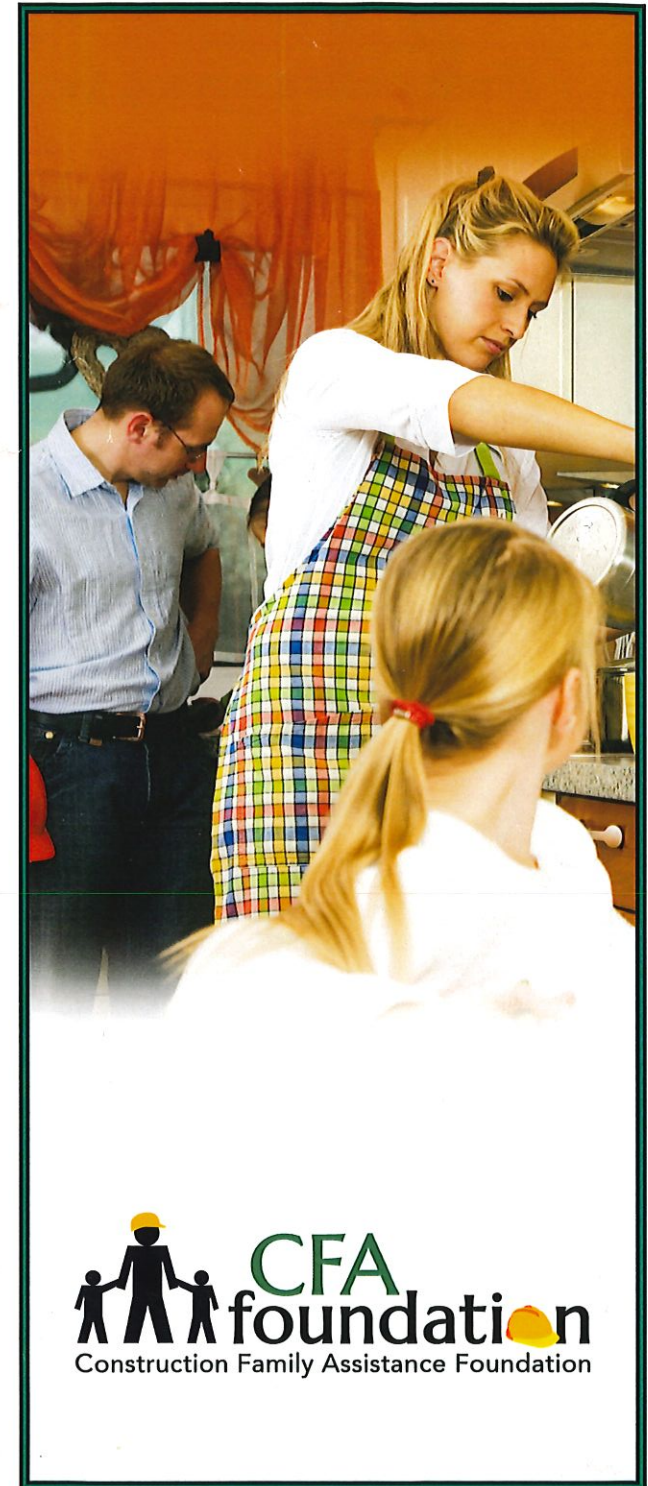

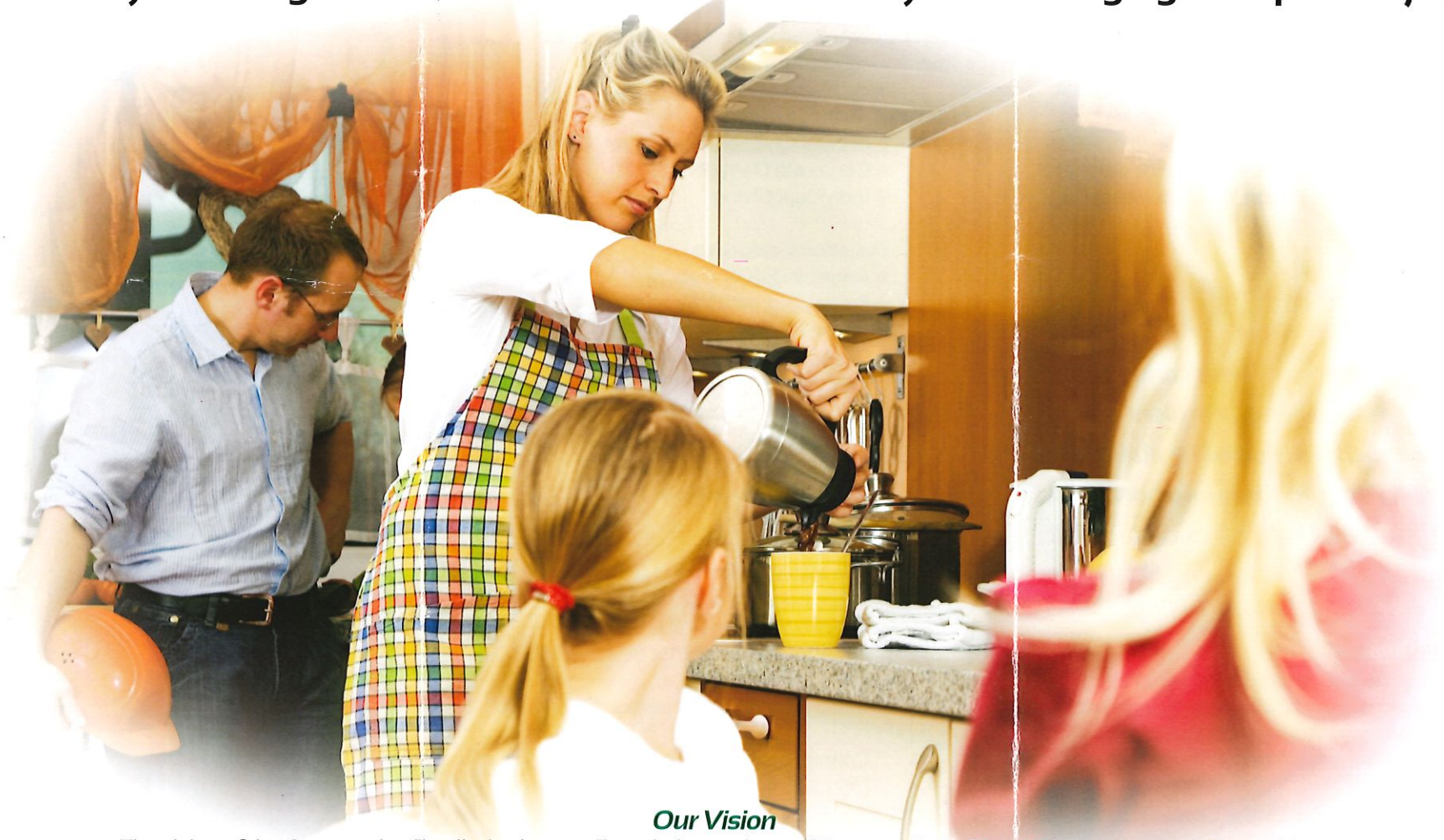

Our Vision

The vision of the Construction Family Assistance Foundation, an Internal Revenue Code 501 (c) (3) organization, is to provide financial assistance to individuals or families affected by a construction or facilities maintenance related incident or loss of life beyond that of workers' compensation, other insurance, or settlements. A workplace injury can quickly and tragically change lives in seconds and the CFA Foundation was created to ease the burden and allow families to begin healing in the most difficult of times.

Our Story

The Construction Family Assistance (CFA) Foundation is the new name of the MICCS Foundation. In 2010, a committee was formed by MICCS, the foundation's sister organization, to develop a plan to establish a 501 (c)(3) charitable organization that would provide financial assistance to individuals or families affected by a construction or facilities maintenance related incident or loss of life beyond that of workers' compensation, other insurance, or settlements. In 2012, that became a reality with the formation of the MICCS Foundation which is now a standalone organization. Led by a board of directors, the foundation has established sizeable retained earnings in order to provide financial assistance when needed. Although this money is available for afflicted individuals and their families, it is the belief of the foundation's board that safety is the most important issue when it comes to construction and facilities maintenance projects.
