Introduction and purpose of the RFI

INDOT is exploring the possibility of creating an RFP for the operation and maintenance of INDOT-owned highway lighting.

INDOT currently operates and maintains approximately 15,650 luminaries (see Appendix A), primarily high-pressure sodium, at an annual cost of approximately \$3.7 million (~60%/40% energy/maintenance). While new facilities, and those within future projects' limits, are reviewed for upgrade via life-cycle cost analysis, INDOT seeks to accelerate lighting operation and maintenance cost savings on the agency's existing infrastructure.

The goal for this RFI and the possible subsequent RFP is to reduce INDOT's annual lighting expenses on the existing infrastructure while maintaining lighting performance in compliance with the AASHTO GL-6 Roadway Lighting Design Guide.

INDOT is requesting information on alternative concepts in highway lighting maintenance including, but not limited to, the use of advanced technologies and alternative energy billing arrangements. By allowing private industry to apprise INDOT of information that should be considered in a potential scope of work, INDOT believes a wide array of creative yet practical solutions will be generated.

An example of an alternative concept would be a fixed-fee contract where the contractor is responsible for operational maintenance and the handling of energy billing and costs, with contractor incentive to install energy-efficient fixtures. However, respondents to this RFI are encouraged to think broadly and creatively in generating solutions.
