

Dear Randy,

This is to inform you of the approval of an administrative amendment to the 2012-2015 Indianapolis TIP. The MPO concluded that the amendment is air quality exempt, per 40 CFR 93.126 & 127, and there is no need to update the conformity analysis or issue a new conformity finding. The Air Quality Consultation Group has been provided a copy of this amendment for informational purposes. The amendment is listed below:

- INDOT - DES # 1297916 - I-465, 2.84 miles west of I-69 at North River Road, bridge maintenance and repair. Add CN to FY 2013 with a total cost of \$24,776 (\$22,298 federal BR funds and \$2,478 state match). CN in FY 2013.
- INDOT - DES # 1297928 - I-70, 2.01 miles west of I-65 in Marion County, signing. Add CN to FY 2013 with a total of \$248,432 (\$223,599 federal IM funds and \$24,843 state match.) CN in FY 2013.

Revised IRTIP Title Pages, and Addendum Tables that incorporate the amendment into the 2012-2015 IRTIP will be available with the next set of quarterly amendments on the MPO website.
