## **Group IV Program: Notice of Funding Availability (NOFA)**

The Indiana Department of Transportation (INDOT) is now accepting applications for federal funds for Group IV projects. Funds are available for development and construction of new projects to be constructed in federal fiscal year 2015 (October 1, 2014– September 30, 2015).

### **Application Information and Deadlines:**

LPA's must electronically submit their application(s) and supporting documents to Michael Cales at [mcales@indot.in.gov](mailto:mcales@indot.in.gov) by midnight May 20, 2011. Failure to meet this deadline and receive a confirmation will result in an ineligible application. Supporting documents are limited to **eight (8) pages** total. LPA's are limited to one (1) application for a new project in addition to applications requesting additional funding to existing projects. Project awards will be announced no later than July 15, 2011.

Applications from LPAs who owe INDOT money, which is more than 60 days past due will NOT be considered. An LPA which resolves its past due account will be eligible for award. The LPA should contact the appropriate District Local Programs Coordinator to discuss its past due account.

### **Eligible Applicants:**

All counties, as well as cities and towns with a population less than 5,000 that are not inside the urbanized area of an MPO are eligible for Group IV funds. Populations from the 2000 U.S. Census will be used for eligibility of the applicants. Each LPA MUST designate a certified Employee in Responsible Charge as defined in Chapter 10 of the INDOT LPA Process Guidance Document. **Only applications submitted by the Certified Employee in Responsible Charge from the LPA will be accepted.**

### **Funding Information:**

The amount of federal funds to be awarded will be \$25,000,000. The maximum award from this Notice of Funding Availability (NOFA) to any applicant is \$3,000,000.00 of federal funds or the total available in its district, whichever is less. The funds will be apportioned by INDOT's geographical districts based on the population of the eligible Group III's. The approximate amount for each INDOT District is as follows:

**Eligibility:**

Road and bridge projects that are on system that are in the jurisdiction of an eligible Group IV county, city or town are eligible for funds from this program (INDOT's roads and streets are not eligible projects). Preventative Maintenance projects are not eligible for funding.

On System refers to those roads described as:

- (1) all arterials (rural or urban);
- (2) all urban collectors;
- (3) all rural major collectors.

Off System refers to those roads described as:

- (1) all rural minor collectors;
- (2) all local roads (rural or urban).

**Selection Process:**

The applications will be scored by the appropriate districts using a combination of factors including but not limited to planning and support of the project, funding commitment, road and safety data, economic development and LPA history.

**Please note: A funding commitment letter from the fiduciary body of the LPA is required with all applications.**
