Please find attached a Metropolitan Planning Organization TIP amendment which must be approved and included into the FY 2014 State Transportation Improvement Program. We will reflect by reference the 2014-2017 federal aid projects covered by this approval in our 2014 - 2017 STIP. The Administrative Amendment is for the Lafayette MPO. The Administrative Amendment was approved on August 4, 2014 by the Lafayette MPO.

By this letter I am administratively modifying the FY 2014-2017 and the FY 2015-2018 TIPs in regard to the CityBus Safety Education project. Both TIPs currently show the project programmed in Table 2 using STP funds. This modification adds the project to CityBus's CY 2013 Capital Project List and it will now be funded with Section 5307 funds rather than STP funds that have been flexed from HSIP funds.

This project will be the eleventh in the CY 2013 list and the Section 5307 funds will come from the allocation to the CNG Fueling Station (construction), des #1382006. The amount of Section 5307 funds to be shifted is \$24,000.

The project description is as follows:

Safety Awareness Campaign DES # 1401150

This project expands a safety campaign that was initiated early in 2014. The campaign focuses on students, faculty and staff around the Purdue campus and its main goal is to heighten awareness regarding distracted pedestrians, cyclists and motorists as well as intoxicated driving. The project includes bus wraps, advertisement, flyers, cards, posters, T-shirts, windbreaks and a display. The total cost of the project is \$30,000.

We are also requesting a des number for the safety project and attached you will find a spreadsheet contained the detailed information.

We have reviewed the State Transportation Improvement Program (STIP) amendment requests you submitted via correspondence dated July 28, 2014 and August 8, 2014. The requests add projects pursuant to changes made to the Transportation Improvement Programs (TIPs) for the Northeastern Indiana Regional Coordinating Council (Fort Wayne MPO), Area Plan Commission of Tippecanoe County (Lafayette MPO), Columbus MPO, and for the Michiana Area Council of Governments (MACOG).

The amended TIPs have been endorsed by the appropriate Metropolitan Planning Organizations (MPOs). The projects listed in the attached STIP amendment table (Attachment 1) are eligible for FTA funding.

We have determined that the amendments to the TIPs and STIP are financially constrained and consistent with the relevant MPO and statewide transportation plans. The projects were developed in accordance with the requirements of 23 CFR 450, and are exempt from the air quality conformity determination process. The project additions are approved for the FY2014-2017 STIP.
