

Dates to Remember

You must submit your retirement application to INPRS no later than 90 days before your retirement date to ensure a smooth transition between your last paycheck and your first benefit payment.

The retirement lifestyle you choose will influence the amount of money you'll need to save to meet your retirement goals. Consider the two-part PERF plan as a portion of your retirement savings.

Defined Benefit (DB)

A lifetime monthly pension payment is the result of 10 or more years of PERF creditable service. You'll receive this guaranteed monthly payment when you meet specific age and service requirements, separate from your employer

and apply for retirement benefits.

Defined Contribution (ASA)

You can supplement your DB with your Annuity Savings Account (ASA) at retirement. The mandatory 3 percent contribution made by you, your employer or a combination of both make up the funds in this account.
