This matter is before the Court on the application for a Writ of Garnishment against the property of Bruce McLaren, defendant, which was filed by the United States of America.

Whereupon the Court, having considered the application for a writ of garnishment against the property of the defendant Bruce McLaren now finds that the requirements of 28 U.S.C. § 3205 are satisfied and that an appropriate writ of garnishment shall, and hereby does, issue.

IT IS THEREFORE ORDERED THAT:

1. A criminal judgment has been entered against the above-named defendant in the amount of \$ [REDACTED]. The balance of that judgment as of March 1, 2005 is \$ [REDACTED].
2. The Garnishee, Public Employees Retirement Fund, is required by law to answer this Writ in writing, under oath, within ten (10) days.
3. The Garnishee shall withhold and retain any property in which the debtor has a substantial nonexempt interest and for which the Garnishee is or may become indebted to the judgment debtor pending further order of this Court.
4. The original written answer to this writ must be filed within ten (10) days of service of the writ with the United States District Clerk at: United States District Court, 46 East Ohio Street, U.S. Courthouse, Room 105, Indianapolis, Indiana 46204.
5. Copies of the answer must also be served upon the debtor, Bruce McLaren, [REDACTED] and upon the United States Attorney, 10 West Market Street, Suite 2100, Indianapolis, Indiana 46204.
6. Pursuant to 28 U.S.C. § 3205(c)(3), the United States shall serve the Garnishee and the Judgment Defendant with copies of this Writ of Garnishment and shall certify to the Court that such service was made. The writ shall be accompanied by the instructions required by 28 U.S.C. § 3205(c)(3)(A) & (B).

**APPLICATION FOR WRIT OF GARNISHMENT
AGAINST THE PROPERTY OF
JUDGMENT DEFENDANT BRUCE MCLAREN**

The plaintiff, the United States of America, by counsel, Susan W. Brooks, United States Attorney for the Southern District of Indiana, and Jill E. Zengler, Assistant United States Attorney, respectfully makes application pursuant to Section 3205(b)(1) of the Federal Debt Collection Procedures Act of 1990, 28 U.S.C. § 3205(b)(1), to the United States District Court to issue a Writ of Garnishment upon the judgment entered against the defendant, Bruce McLaren ("defendant" or "judgment debtor"). In support of this application, the United States provides the following statement pursuant to 28 U.S.C. § 3205(b)(1):

1. The judgment debtor's name is Bruce McLaren, his Social Security Number is XXX-XX-0609, and his last known address is 2800 W. Brayston Way, Muncie, IN 47304.

2. A criminal judgment was entered against the defendant in this action in the amount of \$315,361.04. The sum of \$41,199.45 has been credited to the judgment debt leaving a total balance due of \$274,161.59 as of March 1, 2005.

3. The Garnishee is believed have in its possession, custody, or control, money or property of the judgment debtor, and said property is a nonexempt interest of the debtor.


