**FINAL ORDER**

The Board of Trustees ("Board") of the Indiana Public Retirement System ("INPRS") is the ultimate authority in administrative appeals brought by members of the 1977 Police Officers' and Firefighters' Pension and Disability Fund (the "77 Fund") under IC 4-21.5-3-28 and 35 IAC 2-5-5(a)(7). Pursuant to 35 IAC 1.2-1-2, the Board delegates to the Executive Director the authority to conduct a final authority proceeding, or a review of decision points by the administrative law judge ("ALJ"), to issue a final order in this matter.

1. The ALJ entered an Order of Dismissal ("Order") in this matter on January 16, 2012.
2. Copies of the Order have been served upon the parties.
3. Pursuant to IC 4-21.5-3-29(d)(2) and Indiana Trial Rule 4.17(B)(2), it has been more than fifteen (15) days since the ALJ served the Order upon the parties.

NOW THEREFORE the Decision and the Order of the Administrative Law Judge is affirmed.
