

Indiana Tobacco Free School Policy List

Definition of Tobacco Free School:

School policy that prohibits against any tobacco use by students, all school staff, parents, and visitors on school property, in school vehicles, and at school-sponsored functions away from school property 24 hours a day.

This list includes school corporations that do not have a tobacco free campus based on the CDC definition
