

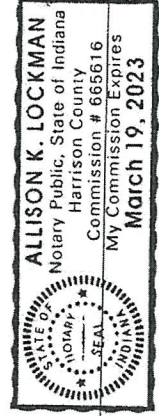

Notice is hereby given that the Edwardsville Water Corporation, Georgetown, Indiana, under and pursuant to the Public Service Commission Act, as amended, intends to file with the Indiana Utility Regulatory Commission on or about January 27, 2016 a request to amend its schedule of automatic sprinkler fees.

The changes in schedules of rates submitted to the Commission are based solely upon the need to include charges or additional automatic sprinkler sizes not currently included on the Corporation's tariff. The change shall apply following final approval by the Commission on March 2, 2016, whichever is later. The proposed change is for automatic sprinkler fees, for all water utility customers, and does not affect retail water rates.
