
Dear Ms. Howe:

**NOTICE OF THIRTY-DAY FILING WITH THE  
INDIANA UTILITY REGULATORY COMMISSION**

On November 4, 2013, Stucker Fork Conservancy District ("District"), filed with the Indiana Utility Regulatory Commission ("IURC") Resolution 2013-2, a Resolution Concerning Stucker Fork Conservancy District's Bad Debt Collection Rules. The Resolution formalizes the District's policy of holding businesses and rental property owners responsible for the outstanding water bills for their respective properties. The Resolution specifically states that the District will only hold the property owner, and not the tenant, responsible for any outstanding District water bills. The District anticipates that the IURC will approve the filing on or before December 4, 2013. **RESOLUTION 2013-2**

**A RESOLUTION CONCERNING STUCKER FORK CONSERVANCY DISTRICT'S  
BAD DEBT COLLECTION RULES**

**WHEREAS**, in March of 2003, the Board of Directors ("Board") for the Stucker Fork Conservancy District ("District") approved a motion to alter its bad debt rules; and

**WHEREAS**, pursuant to the March, 2003 motion, the District determined that for all properties, including business and rental properties, the property owner is the customer responsible for the payment of all water bills; and

**WHEREAS**, the District requires that a property owner (and not a tenant) be responsible for any unpaid bills for service to the property; and

**WHEREAS**, on October 2, 2013, the Indiana Utility Regulatory Commission ("IURC") in Cause No. 44164 entered an Order requiring the District to memorialize its bad debt rules in writing; and

**WHEREAS**, the Board desires to memorialize its rules pursuant to the IURC order.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS FOR  
THE STUCKER FORK CONSERVANCY DISTRICT** as follows:

**Sec. 1:** For all properties, including businesses and rental properties, the District shall treat the property owner (not the tenant) as the customer.

**Sec. 2:** In the event a bill goes unpaid, the District shall only hold the property owner responsible to pay for the bill.

**Sec. 3:** Stucker Fork's attorneys are hereby authorized to file this Resolution with the IURC consistent with the IURC's October 2, 2013 Order in Cause No. 44164.


