

You are hereby notified that on this date the Indiana Utility Regulatory Commission ("Commission") caused the following entry to be made:


Pursuant to the terms of a Docket Entry issued by the Presiding Officers on December 15, 2006, an Attorneys' Conference was conducted in this matter on January 11, 2007. One of the issues discussed at the Attorneys' Conference was the composition of the Indiana Universal Service Fund Oversight Committee ("Oversight Committee" or "Committee") which had several vacancies due the expiration of terms of some of the members.

On February 1, 2007, the Presiding Officers issued a Docket Entry in this matter in which they reappointed certain members of the Oversight Committee and requested nominations to fill the vacant RLEC position on the Committee. In response to the Docket Entry the Commission received the nomination of Mr. Bruce A. Hazelett from the Board of Directors of the Indiana Exchange Carrier Association, Inc., ("INECA"). No other nominations were received by the Commission.


Accordingly, the Presiding Officers find that Mr. Bruce A. Hazelett should be appointed as the RLEC representative to the Oversight Committee. The current composition of the Oversight Committee is as follows:
