### Opportunity for Public Comment on Eastern Bartholomew Water's Rate Case

**What:** A field hearing will be held in Taylorsville by the Indiana Utility Regulatory Commission (Commission) to hear from the public on the rate case petition of Eastern Bartholomew Water Corporation under [Cause No. 44903](#).

**When:** May 18, 2017, at 7 p.m.

**Where:** Taylorsville Elementary School (Cafeteria), 9711 Walnut Street, Taylorsville, IN 47280

**Why:** Eastern Bartholomew Water has filed a petition before the Commission for a new schedule of rates and charges for water service.

**How:** During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the commissioners and judge are not allowed to answer questions or engage in any discussion about the case.
