## Opportunity for Public Comment on Citizens Gas of Westfield's Rate Case

What: A field hearing will be held in Westfield by the Indiana Utility Regulatory Commission (Commission) to hear from the public on Citizens Gas of Westfield's rate case petition, under Cause No. 44731. Please note that this field hearing is only for comments regarding Citizens Gas of Westfield's rate case petition. A separate field hearing for the Citizens Wastewater of Westfield rate case petition (Cause No. 44835) will be held on Nov. 3, 2016, at Westfield Middle School.

**When:** Oct. 12, 2016, at 6 p.m. EST. Prior to the hearing, the Office of Utility Consumer Counselor (OUCC) will hold an educational session at 5:30 p.m. EST.

Where: Westfield High School, 18250 N. Union Street, Westfield, Indiana

**Why:** Citizens Gas of Westfield has filed a petition before the Commission for a new schedule of rates and charges for natural gas service.

**How:** During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the commissioners and judge are not allowed to answer questions or engage in any discussion about the case.
