## **Opportunity for Public Comment on Citizens Wastewater of Westfield's Rate Case**

- What: A field hearing will be held in Westfield by the Indiana Utility Regulatory Commission (Commission) to hear from the public on Citizens Wastewater of Westfield's rate case petition, under Cause No. 44835. Please note that this field hearing is only for comments regarding Citizens Wastewater of Westfield's rate case petition. A separate field hearing for the Citizens Gas of Westfield rate case petition (Cause No. 44731) was held on Oct. 12, 2016.
- When: Nov. 3, 2016, at 6 p.m. EST.

Where: Westfield Middle School, 345 W. Hoover Street, Westfield, Indiana

- **Why:** Citizens Wastewater of Westfield has filed a petition before the Commission for a new schedule of rates and charges for sewer service.
- **How:** During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the commissioners and judge are not allowed to answer questions or engage in any discussion about the case.
