**Why:** Frankfort Municipal Light & Power has filed a petition before the Commission for a new schedule of rates and charges for electric service.

**How:** During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the commissioners and judge are not allowed to answer questions or engage in any discussion about the case.
