The Indiana Utility Regulatory Commission (the "Commission" or "IURC"), pursuant to IC 8-1-1-3(g) and 4-22-2.5-2, hereby readopts 170 IAC 7 regarding telephone utilities; 170 IAC 15 regarding landlord distributing water or sewage disposal service; and 170 IAC 16 regarding customer complaints.

A notice of intent was published on May 11, 2016, in the Indiana Register. No requests for any part of this readoption to be separated from this action were submitted in writing within 30 days of this publication. On July 6, 2016, at 2:00 p.m. EDT, in the IURC Conference Center Suite 220, PNC Center, Indianapolis, Indiana, a majority of the members of the Commission were present and adopted the foregoing rule.


The Commission's General Counsel shall forward copies of the attached rule to the Indiana Legislative Services Agency for publication in the Indiana Register.


