

Requests: The FCC recently approved administrative and formatting changes to various portions of the NECA interstate access tariff, in response to Tr. 1228, 1231, and 1232. These revisions do not change existing interstate or intrastate tariff rates and charges or the terms and conditions under which interstate or intrastate access service is provided.

The FCC recently approved a decrease in the Federal Universal Service Charge (FUSC) for NECA, in response to Tr. 1229. CCI does not mirror the FUSC. Therefore, CCI needs to maintain an existing exception in its intrastate switched access tariff. Furthermore, NECA FUSC modifications do not result in any modifications to the Indiana Universal Service Fund (IUSF) monthly surcharge, which was established by this Commission in Cause No. 42144.

The FCC approved the first phase of a new interstate tariff structure (i.e., rate bands) for three Tandem Switched Transport (TST) rate elements (Tr. 1229) and subsequently approved the second phase of the new rate band structure (new rate band assignments for some companies) and reduced certain TST rates (Tr. 1232). CCI mirrors the new rate band structure in its intrastate switched access tariff and will mirror the TST rate reductions for its assigned rate band.

Requests: The FCC recently approved a new federal USF Recovery Charge surcharge for Frontier of Rochester, in response to Tr. 111. The Indiana USF (IUSF) surcharge does not mirror the USF Recovery Charge; therefore, Frontier of Thorntown needs to maintain this existing exception in its intrastate access tariff. Frontier of Rochester's federal USF modifications do not result in any modifications to the IUSF surcharge, which this Commission established in Cause No. 42144.

The FCC recently approved a new contract tariff offering for Frontier of Rochester, in response to Tr. 112. This contract tariff is not available in Indiana, so Frontier of Thorntown must take an exception to this portion of Frontier of Rochester's interstate access tariff.
