**Request:** On November 12, 2009 the Commission approved a change in the expiration of two experimental tariffs and the experimental rider associated with I&M's Smart Meter Pilot Program ("SMPP") from 12/31/2009 to 09/30/2010. The expiration date of 09/30/2010 was an error by Staff. I&M had requested the expiration date of 03/31/2011 to allow time for the analysis of the results of the pilot and not disrupt the customers that have volunteered for service under these experimental tariffs before any decision regarding the future of the tariffs must be determined.
