Request: This is a tariff revision for Indiana Bell Tel. Co., Inc., d/b/a AT&T Indiana. The purpose of the filing is to add intrastate exceptions to AT&T Indiana's intrastate (IURC) access tariff to grandfather certain special access term plans greater than 36 months duration for DS1, DS3, Base Rate (DS0), and Direct Analog Service. These term plans are available in AT&T's interstate (FCC) access tariff; however, the term plans in question will no longer be available for either new or renewed intrastate special access customers, effective December 5, 2013.
