ORDER OF THE COMMISSION



Request: Crawfordsville Electric Light & Power (CEL&P)], an electric utility, requests to add a new rate schedule to their rates and charges, Rate Schedule DWC (Distribution Wheeling Charge). This new rate schedule will have one customer, Crawfordsville Energy, LLC. The new rate is necessary as a result of a transaction in which the CEL&P electricity generating plant will be sold to Crawfordsville Energy, LLC.

Pursuant to the Asset Purchase Agreement, Section 19(d), by and between the City of Crawfordsville, Indiana and Crawfordsville Energy, LLC:

Seller [CEL&P] will provide access to the electricity transmission grid to Purchaser [Crawfordsville Energy, LLC] through its existing transformers. Purchaser shall pay the fee for this service set forth on the non-discriminatory tariff to be filed with and approved by the IURC and Seller's municipal legislative body [the Common Council of the City of Crawfordsville][.]

Based on the terms of the Asset Purchase Agreement Section 19(d), a rate consultant with ISC, Inc. developed the Rate Schedule DWC monthly fee to be \$3,749.00.

Customer Impact: This rate affects only the parties of the Purchase Agreement.

Tariff Page(s) Affected: Crawfordsville Electric Light & Power, Rate Schedule DWC

Staff Recommendations: This filing meets the allowable filings under 170 IAC 1-6-3-1 as it is a rate schedule for a new service. Staff has reviewed the work papers submitted by CEL&P from the consultant used for the development of new rate, Rate Schedule DWC. Staff believes sound rate-making principles were used in the development of the monthly fee for the new rate. The reduction of the amount of CEL&P's plant designated as used to wheel power for Crawfordsville Energy, LLC from what was used to develop CEL&P's current rates would have a de minimis impact to current rates. Staff recommends approval.
