

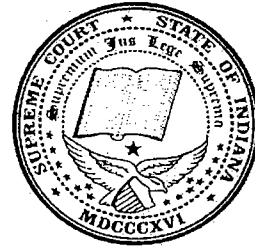

Caseload Information

Volume II of the *Indiana Judicial Report* reflects caseload information for every court in Indiana with subtotals for each county. This includes data on the number and type of cases pending in each court at the beginning of the year, new cases filed, cases transferred and venued to each court during the reporting year, the number and type of cases disposed by each court, and the number pending at the end of the reporting year. In addition, this volume reflects the method of case disposition in each court as well as detailed data on other judicial activities.

For a description of the Indiana judicial system, data on Indiana's appellate level courts, state-wide totals and comparison tables and trends, the reader should refer to *Volume I – Executive Summary* of this report. Volume III of this report contains data on the expenditures and revenues of every court in Indiana.
