** As of October 9, 2012 it is no longer necessary to create a CB case to record a Department of Revenue Tax Warrant.

***Opening an EU case and assessing fees is only required if the affiant requests a court order to enforce the affidavit. If no court order is requested, no EU case is opened.

****Opening case is not required; for tracking purposes in a Case Management System, use CB.
