

**Order Appointing Members to the Advisory Commission on  
Guardian Ad Litem/ Court Appointed Special Advocate Services**

Pursuant to I.C. 33-24-6-4, the Supreme Court established an office of guardian ad litem and court appointed special advocate (GAL/CASA) services. This office is responsible for the distribution of matching funds appropriated for certified county GAL/CASA programs, the dissemination of information, and training and communication services for these programs.

On February 24, 1993, this Court established a twelve (12) member Indiana Supreme Court Advisory Commission on GAL/CASA to assist the Court and the GAL/CASA office in the performance of their duties. On January 22, 1994, this Court increased the membership of the Advisory Commission to eighteen (18) members. In September 2007, this Court amended the Administrative Rules to add Rule 4(E), effective on January 1, 2008, which formalized the creation and duties of the Advisory Commission.

Pursuant to Administrative Rule 4(E)(1), regarding the selection of members to the Advisory Commission, this Court has been advised that the following individuals have been recommended by their peers to be members of the Advisory Commission for the indicated terms:
