**ORDER AMENDING SERVICE DAY LIMITS FOR SENIOR JUDGES  
FOR CALENDAR YEAR 2008**

On January 31, 2008, this Court issued an Order establishing service day limits for senior judges in each trial court for calendar year 2008. The judges set forth below have requested an increase in the number of senior judge service days allotted to their courts.

And this Court, being duly advised, now finds that each judge has established sufficient reasons for the allotment of additional senior judge service days for calendar year 2008.

IT IS, THEREFORE, ORDERED that the number of senior judge service days allotted to each court for calendar year 2008 is as follows:


