HOUSE MOTION _____

MR. SPEAKER:

I move that House Bill 1001(ss) be amended to read as follows:

- 1 Page 361, between lines 9 and 10, begin a new paragraph and insert:
- 2 "SECTION 403. [EFFECTIVE UPON PASSAGE] (a) As used in
- 3 this SECTION, "local project" means an item for which an
- 4 appropriation was made under P.L.291-2001, SECTION 38, under
- 5 the title "FOR THE BUDGET AGENCY-LOCAL PROJECTS".
- 6 (b) As used in this SECTION, "recipient" means the entity
- 7 either:
- 8 (1) specifically identified by; or
- 9 (2) reasonably ascertainable from the language of;
- 10 P.L.291-2001, SECTION 38, as the entity to which an
- 11 appropriation for a local project was made, regardless of whether
- 12 the entity is a private or public entity or the project is a capital
- 13 project.
- 14 (c) The local projects fund is established for the purpose of
- 15 funding local projects.
- 16 (d) The fund shall be administered by the budget agency.
- 17 (e) As soon as possible after the effective date of this SECTION,
- 18 fifty million one hundred thirty-four thousand six hundred dollars
- 19 (\$50,134,600) shall be transferred from the state general fund to
- 20 the local projects fund.
- 21 (f) Subject to subsection (g), immediately after money is
- 22 transferred into the local projects fund under subsection (e), the
- 23 budget agency shall distribute the amount of each local project

1 appropriation made by P.L.291-2001, SECTION 38, to the
2 recipient for that local project. If sufficient money is not available
3 in the local projects fund to fully fund all the local projects for
4 which funds were appropriated by P.L.291-2001, SECTION 38, the
5 budget agency shall proportionately reduce the amount to be
6 distributed to each local project and distribute the reduced amount
7 to the recipient for the local project.

8 (g) As the only condition of receiving a distribution under this
9 SECTION, an individual with authority to act on behalf of a
10 recipient must enter into an agreement with the budget agency,
11 signed under penalties of perjury, that commits the recipient to
12 using the money distributed under this SECTION for the purpose
13 for which the money was initially appropriated under
14 P.L.291-2001, SECTION 38. Immediately after the effective date
15 of this SECTION, the budget agency shall prepare an agreement
16 form to carry out this subsection. The budget agency shall
17 immediately post the form through Access Indiana on its web page
18 on the Internet in a printable format. The budget agency shall
19 make written copies of the form available upon request. Any
20 agency or public official required by law to review the form shall
21 review the form in an expedited manner to carry out the purposes
22 of this SECTION. Receipt of the signed agreement by the budget
23 agency in the form required under this SECTION constitutes
24 compliance with this SECTION and no further agreement or
25 project reviews or approvals are required to be eligible for or to
26 make a distribution under this SECTION.

27 (h) The distributions required under subsections (e) and (f), are
28 appropriated, beginning on the effective date of this SECTION,
29 and continue to be appropriated until the purposes of this
30 SECTION are carried out. The money is automatically allotted for
31 the purposes of this SECTION. Notwithstanding IC 4-12-1-12,
32 IC 4-13-2-8, or any other law granting allotment powers or powers
33 to transfer, assign, or reassign appropriations to the budget
34 agency, the budget agency shall allot the amounts appropriated
35 under this subsection to carry out the purpose of this SECTION to
36 fund each local project as provided in subsection (f).
37 Notwithstanding IC 4-9.1-1-7 or any other law granting power to
38 the state board of finance to transfer money among funds or
39 between appropriations, money may not be transferred from the
40 local projects fund for any purpose other than the purposes
41 described in this SECTION and may not be used for any
42 appropriation other than the appropriation made by this
43 subsection.

44 (i) The amount of the appropriation that P.L.291-2001,
45 SECTION 38, authorizes the budget agency to make from the build
46 Indiana fund to a local project is reduced to the extent that money
47 is distributed to the local project under this SECTION.

- 1 **(j) Money in the fund at the end of a state fiscal year does not**
- 2 **revert to the state general fund. The local projects fund terminates**
- 3 **June 30, 2003.**
- 4 **(k) This SECTION expires July 1, 2003."**
- 5 Renumber all SECTIONS consecutively.
