ENGROSSED HOUSE BILL No. 1260

DIGEST OF HB 1260 (Updated February 17, 1998 12:37 pm - DI 71)

Citations Affected: IC 9-13; IC 20-9.1.

Synopsis: School buses. Provides that the definition of "school" for the purposes of traffic regulations concerning school buses includes preschool. Provides that a person who drives a school bus must: (1) have sufficient physical ability to be a school bus driver, as determined by the state school bus committee; and (2) be free from any communicable disease that is transmitted through airborne or droplet means or that requires isolation of the infected person. Requires the state school bus committee to adopt rules to prescribe performance standards and measurements for determining the physical ability necessary for a person to be a school bus driver.

Effective: July 1, 1998.

ENGROSSED HOUSE BILL No. 1260

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 9-13-2-160.5 IS ADDED TO THE INDIANA
2 CODE AS A NEW SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 1998]: **Sec. 160.5. "School", for purposes of:**
4 (1) **section 161(b) of this chapter as it pertains to IC 9-21-12;**
5 **and**
6 (2) **IC 9-21-12;**
7 **includes preschool.**
- 8 SECTION 2. IC 20-9.1-3-1, AS AMENDED BY P.L.155-1997,
9 SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
10 JULY 1, 1998]: Sec. 1. A person may not drive a school bus for the
11 transportation of school children or be employed as a school bus
12 monitor unless the person satisfies the following requirements:
13 (1) Is of good moral character.
14 (2) Does not use intoxicating liquor during school hours.
15 (3) Does not use intoxicating liquor to excess at any time.
16 (4) Is not addicted to any narcotic drug.

- 1 (5) Is at least twenty-one (21) years of age.
 2 (6) Holds a valid public passenger chauffeur's license or
 3 commercial driver's license issued by the state of Indiana or any
 4 other state.
 5 (7) Possesses the following required physical characteristics:
 6 (A) Sufficient physical ability to ~~drive~~ **be a school bus driver,**
 7 **as determined by the state school bus committee**
 8 **(IC 20-9.1-4-1).**
 9 (B) Possession and full normal use of both hands, both arms,
 10 both feet, both legs, both eyes, and both ears.
 11 (C) Freedom from any communicable disease **that:**
 12 **(i) may be transmitted through airborne or droplet**
 13 **means; or**
 14 **(ii) requires isolation of the infected person under 410**
 15 **IAC 1-2.1.**
 16 (D) Freedom from any mental, nervous, organic, or functional
 17 disease which might impair the person's ability to properly
 18 operate a school bus.
 19 (E) Visual acuity, with or without glasses, of at least 20/40 in
 20 each eye and a field of vision with 150 degree minimum and
 21 with depth perception of at least 80%.
- 22 However, subdivisions (6) and (7) do not apply to the employment of
 23 a school bus monitor.
- 24 SECTION 3. IC 20-9.1-4-4 IS AMENDED TO READ AS
 25 FOLLOWS [EFFECTIVE JULY 1, 1998]: Sec. 4. (a) The state school
 26 bus committee has the following powers:
- 27 (1) It may prescribe, by rules adopted under IC 4-22-2, standards
 28 for the construction of school buses, including minimum
 29 standards for the construction of school buses necessary to be
 30 issued a:
 31 (A) valid certificate of inspection decal; and
 32 (B) temporary certificate of inspection decal described in
 33 section 5.1 of this chapter.
- 34 (2) It may prescribe, by rules adopted under IC 4-22-2, standards
 35 for the equipment of school buses, including minimum standards
 36 for the equipment of school buses necessary to be issued a:
 37 (A) valid certificate of inspection decal; and
 38 (B) temporary certificate of inspection decal described in
 39 section 5.1 of this chapter.
- 40 (3) It may specify by rules adopted under IC 4-22-2 the particular
 41 minimum standards that are required to be met to avoid the
 42 issuance of an out-of-service certificate of inspection decal.

- 1 (4) It may provide for the inspection of all school buses, new or
- 2 old, which are offered for sale, lease or contract.
- 3 (5) It may provide for the annual inspection of all school buses
- 4 and the issuance of certificate of inspection decals.
- 5 (6) It may maintain an approved list of school buses which have
- 6 passed inspection tests under subdivisions (4) or (5).
- 7 (7) It may, subject to approval by the state board of accounts,
- 8 prescribe standard forms for school bus contracts.
- 9 (8) It may hear appeals brought under section 7 of this chapter.
- 10 **(b) The state school bus committee shall adopt rules under**
- 11 **IC 4-22-2 to prescribe performance standards and measurements**
- 12 **for determining the physical ability necessary for a person to be a**
- 13 **school bus driver.**
- 14 (c) The certificate of inspection decals shall be issued to correspond
- 15 with each school year. Each certificate of inspection decal expires on
- 16 September 30 following the school year in which the certificate of
- 17 inspection decal is effective. However, for buses that are described in
- 18 section 5(g) of this chapter, the certificate of inspection decal expires
- 19 on a date that is not later than seven (7) months after the date of the
- 20 first inspection for the particular school year.

Each school bus used to transport school children in Indiana that is purchased after June 30, 2000, must be equipped with a school bus crossing arm that meets or exceeds Society of Automotive Engineers (SAE) specifications.**"

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 9-13-2-161 IS AMENDED TO READ AS FOLLOWS: Sec. 161. (a) "School bus" means, except as provided in subsection (b), a bus, hack, conveyance, or motor vehicle used to transport school children to and from school and to and from school athletic games or contests or other school functions. The term does not include a privately owned automobile with a capacity of not more than five (5) passengers that is used for the purpose of transporting school children to and from school.

(b) "School bus", for purposes of IC 9-21, means a motor vehicle owned by a public or governmental agency and operated for the transportation of children to or from school, **including project headstart**, or privately owned and operated for compensation for the transportation of children to and from ~~school~~: **school, including project headstart.**"
