DIGEST OF SB148 (Updated February 12, 1998 1:49 pm - DI 77)

**Citations Affected:** None (noncode).

**Synopsis:** Autism waiver. Instructs the office of Medicaid policy and planning to seek approval from the United States Department of Health and Human Services to convert the home and community based services waiver for individuals with autism from a model waiver into a regular waiver. (The introduced version of this bill was prepared by the Indiana Commission on Autism.)

**Effective:** July 1, 1998.

## ENGROSSED SENATE BILL No. 148

A BILL FOR AN ACT concerning human services.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. P.L.112-1997, SECTION 5, IS AMENDED TO READ  
2 AS FOLLOWS [EFFECTIVE JULY 1, 1998]: SECTION 5. (a) As used  
3 in this SECTION, "environmental modifications" means adjustments  
4 to the home environment of a person with autism, including providing  
5 ramps for wheelchair accessibility, handrails, and vehicle modifications  
6 designed to assist in the person's ability to remain in the community.  
7 (b) As used in this SECTION, "personal assistance" means personal  
8 care services for a person with autism, including assistance with  
9 personal grooming, cooking, feeding, and homemaking to assist in the  
10 person's ability to remain in the community.  
11 (c) As used in this SECTION, "waiver" refers to a home and  
12 community based services waiver described in 42 U.S.C. 1396n(c) as  
13 it:  
14 (1) applies to persons with autism; and  
15 (2) is in effect on July 1, 1997.  
16 (d) The office of Medicaid policy and planning shall seek approval  
17 under 42 U.S.C. 1396 et seq. from the United States Department of

- 1 Health and Human Services to amend the waiver as follows:
- 2 (1) Each year during the course of the waiver renewal period raise
- 3 the number of eligible persons who may be served by the waiver
- 4 as follows:
- 5 (A) From ninety (90) to one hundred forty-five (145) during
- 6 the state fiscal year beginning July 1, 1997, and ending June
- 7 30, 1998.
- 8 (B) From one hundred forty-five (145) to two hundred (200)
- 9 during state fiscal years beginning after June 30, 1998.
- 10 (2) Provide for personal assistance and environmental
- 11 modifications for a person with autism who:
- 12 (A) is eligible to use the home and community based services
- 13 waiver for persons with autism under 42 U.S.C. 1396n(c); and
- 14 (B) would otherwise require a level of care provided in an
- 15 intermediate care facility for the mentally retarded (as defined
- 16 in 42 U.S.C. 1396d(d)) in the absence of home and community
- 17 based services described under this subdivision.
- 18 **(3) Convert the waiver into a regular waiver as described by**
- 19 **42 CFR 441.305 (a).**
- 20 (e) The personal assistance and environmental modifications
- 21 required under subsection (d) must be comparable to the services
- 22 available under the intermediate care facility for the mentally retarded
- 23 (ICF/MR) waiver.
- 24 (f) The office of Medicaid policy and planning shall apply for
- 25 approval from the federal Health Care Financing Administration to
- 26 amend the waiver to implement this SECTION before January 1, 1998.
- 27 (g) The office of Medicaid policy and planning may not implement
- 28 the changes listed under subsection (d) until the office of Medicaid
- 29 policy and planning files an affidavit with the governor that attests that
- 30 the federal Health Care Financing Administration has approved the
- 31 changes in the waiver requested by the office of Medicaid policy and
- 32 planning under this SECTION.
- 33 (h) The office of Medicaid policy and planning shall adopt rules
- 34 under IC 4-22-2 necessary to implement this SECTION.
- 35 (i) This SECTION expires July 1, 2002.
