HOUSE MOTION _____

MR. SPEAKER:

I move that House Bill 1312 be amended to read as follows:

Page 1, after line 11, begin a new paragraph and insert:

- 1 SECTION 2. [EFFECTIVE JULY 1, 1998] (a) This SECTION
- 2 applies only to a county having a consolidated city.
- 3 (b) As used in this SECTION, "commission" refers to the
- 4 Marion County transition commission established under subsection
- 5 (f).
- 6 (c) A county wide public question shall be placed on the ballot
- 7 at a special election held November 4, 1998, asking the voters of the
- 8 county whether the county should remain a consolidated city. The
- 9 public question must read as follows: "Should the General
- 10 Assembly amend Indiana law to discontinue UNIGOV in Marion
- 11 County?".
- 12 (d) The county election board shall tabulate the votes cast on
- 13 the public question described in this SECTION and certify the
- 14 results under IC 3-12-4-9 to the state election commission.
- 15 (e) Subject to this SECTION, IC 3-10-3 and IC 3-10-8 apply to
- 16 the election required by this SECTION.
- 17 (f) If the county election board certifies to the state election
- 18 commission that the public question described in subsection (c) has
- 19 been approved by a majority of the voters voting in the election on
- 20 which the question was on the ballot, the Marion County transition
- 21 commission is established.
- 22 (g) The commission consists of eleven (11) members appointed
- 23 as follows:
- 24 (1) Four (4) members of the general assembly appointed as
- 25 follows:

- 1 (A) One (1) senator appointed by the president pro
2 tempore of the senate.
3 (B) One (1) senator appointed by the minority leader of
4 the senate.
5 (C) One (1) representative appointed by the speaker of
6 the house of representatives. The member appointed
7 under this subdivision serves as chairman of the
8 commission until elections are conducted under
9 subsection (h).
10 (D) One (1) representative appointed by the minority
11 leader of the house of representatives.
12 (2) Two (2) members of the Indianapolis, Marion County
13 city-county council appointed as follows:
14 (A) One member of the city-county council appointed by
15 the president of the council.
16 (B) One member of the city-county council appointed by
17 the minority leader of the council.
18 (3) The mayor or the mayor's designee of the following
19 cities:
20 (A) Beech Grove.
21 (B) Indianapolis.
22 (C) Lawrence.
23 (D) Speedway.
24 (E) Southport.
25 (h) The commission shall hold its first meeting not later than
26 sixty (60) days after certification of approval of the public question
27 under subsection (c). At the commission's first meeting, the
28 commission shall elect from among the commission's members a
29 chairman and a vice chairman. A majority of all appointed
30 members constitutes a quorum.
31 (i) The commission shall study and make recommendations
32 concerning all matters relating to the discontinuation of Marion
33 County as a consolidated city, including the following:
34 (1) The division of debt, assets, and equipment.
35 (2) Necessary statutory and ordinance changes.
36 (3) Public health and safety issues, including fire service,
37 police service, and solid waste collection.
38 (j) This SECTION expires July 1, 2001.
