# HOUSE MOTION \_\_\_\_\_

**MR. SPEAKER:**

I move that House Bill 1221 be recommitted to a Committee of One, its author, with specific instructions to amend as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 4-4-12-1 IS AMENDED TO READ AS
- 4 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 1. (a) As used in
- 5 this chapter, "director" means the lieutenant governor, who is also the
- 6 director of the department of commerce.
- 7 (b) As used in this chapter, "eligible entity" means:
- 8 (1) a city;
- 9 (2) a town;
- 10 (3) a county;
- 11 (4) a special taxing district;
- 12 (5) an economic development commission established under
- 13 IC 36-7-12;
- 14 (6) a nonprofit corporation;
- 15 (7) a corporation established under IC 23-7-1.1 (before its repeal
- 16 on August 1, 1991) or IC 23-17 for the purpose of distributing
- 17 water for domestic and industrial use;
- 18 (8) a regional water, sewage, or solid waste district;
- 19 (9) a conservancy district that includes in its purpose the
- 20 distribution of domestic water or the collection and treatment of
- 21 waste; **or**
- 22 (10) the Indiana development finance authority established under
- 23 IC 4-4-11; **or**

1           **(11) the Indiana port commission established under**  
2           **IC 8-10-1.**  
3           (c) As used in this chapter, "industrial development program"  
4 means any program designed to aid economic development in Indiana,  
5 and includes:  
6           (1) the construction of airports, airport facilities, and tourist  
7           attractions;  
8           (2) the construction, extension, or completion of:  
9               (A) sanitary sewerlines, storm sewers, and other related  
10              drainage facilities;  
11              (B) waterlines;  
12              (C) roads and streets;  
13              (D) sidewalks; and  
14              (E) rail spurs and sidings;  
15           (3) the leasing, purchase, construction, repair, and rehabilitation  
16           of property, both real and personal; and  
17           (4) the preparation of surveys, plans, and specifications for the  
18           construction of publicly owned and operated facilities, utilities,  
19           and services."  
20           Page 13, after line 37, begin a new paragraph and insert:  
21           "**SECTION 17. An emergency is declared for this act.**".  
22           Renumber all SECTIONS consecutively.  
              (Reference is to HB 1221 as reprinted January 30, 1998.)
