# HOUSE MOTION \_\_\_\_\_

**MR. SPEAKER:**

I move that House Bill 1145 be amended to read as follows:

- 1 Page 2, between lines 36 and 37 insert:
- 2 "(S) IC 9-18-38 (D.A.R.E. Indiana trust license plates);"
- 3 Page 12, after line 27 insert:
- 4 "SECTION 14. IC 9-18-38 IS ADDED TO THE INDIANA CODE
- 5 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 6 JULY 1, 1998]:
- 7 **Chapter 38. D.A.R.E. Indiana Trust License Plates**
- 8 **Sec. 1. The bureau of motor vehicles shall design and issue a**
- 9 **D.A.R.E. Indiana trust license plate. The D.A.R.E. Indiana trust**
- 10 **license plate shall be designed and issued as a special group**
- 11 **recognition license plate under IC 9-18-25.**
- 12 **Sec. 2. A D.A.R.E. Indiana trust license plate designed under**
- 13 **IC 9-18-25 must include the following:**
- 14 (1) A basic design for the plate, with consecutive numbers or
- 15 letters, or both, to properly identify the vehicle.
- 16 (2) A background design, an emblem, or colors that
- 17 designate the license plate as a D.A.R.E. Indiana trust license
- 18 plate.
- 19 (3) Any other information the bureau considers necessary.
- 20 **Sec. 3. After December 31, 1998, a person who is eligible to**
- 21 **register a vehicle under this title is eligible to receive a D.A.R.E.**
- 22 **Indiana trust license plate under this chapter upon doing the**
- 23 **following:**
- 24 (1) Completing an application for a D.A.R.E. Indiana trust
- 25 license plate.
- 26 (2) Paying the fees under section 4 of this chapter.
- 27 **Sec. 4. (a) The fees for a D.A.R.E. Indiana trust license plate**

1 are as follows:  
2 (1) The appropriate fee under IC 9-29-5-38(a).  
3 (2) An annual fee of twenty-five dollars (\$25).  
4 (b) The annual fee referred to in subsection (a)(2) shall be  
5 collected by the bureau.  
6 (c) The annual fee described in subsection (a)(2) and the  
7 donations described in subsection (d) shall be deposited in the fund  
8 established by section 5 of this chapter.  
9 (d) Subject to IC 5-14-3-4(b)(15), the commissioner may  
10 receive donations for deposit in the fund established by section 5 of  
11 this chapter.  
12 Sec. 5. (a) The D.A.R.E. Indiana trust fund is established.  
13 (b) The treasurer of state shall invest the money in the fund  
14 not currently needed to meet the obligations of the fund in the same  
15 manner as other public trust funds are invested. Interest that  
16 accrues from these investments shall be deposited in the fund.  
17 (c) The commissioner shall administer the fund. Expenses of  
18 administering the fund shall be paid from money in the fund.  
19 (d) On June 30 of each year the commissioner shall distribute  
20 the money from the fund to D.A.R.E. Indiana, Inc."
