MR. SPEAKER:

I move that House Bill 1145 be amended to read as follows:

- 1 Page 2, between lines 36 and 37, begin a new paragraph and
- 2 insert:
- 3 "(S) IC 9-18-38 (Indiana antique car museum trust license
- 4 plates);"
- 5 Page 12, after line 27 insert:
- 6 "SECTION 14. IC 9-18-38 IS ADDED TO THE INDIANA CODE
- 7 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 8 JULY 1, 1998]:
- 9 Chapter 38. Indiana Antique Car Museum Trust License
- 10 Plates
- 11 Sec. 1. The bureau of motor vehicles shall design and issue an
- 12 Indiana antique car trust license plate. The Indiana antique car
- 13 museum trust license plate shall be designed and issued as a special
- 14 group recognition license plate under IC 9-18-25.
- 15 Sec. 2. An Indiana antique car museum trust license plate
- 16 designed under IC 9-18-25 must include the following:
- 17 (1) A basic design for the plate, with consecutive numbers or
- 18 letters, or both, to properly identify the vehicle.
- 19 (2) A background design, an emblem, or colors that
- 20 designate the license plate as an Indiana antique car museum
- 21 trust license plate.
- 22 (3) Any other information the bureau considers necessary.
- 23 Sec. 3. After December 31, 1998, a person who is eligible to
- 24 register a vehicle under this title is eligible to receive an Indiana
- 25 antique car museum trust license plate under this chapter upon
- 26 doing the following:
- 27 (1) Completing an application for an Indiana antique car

1 museum trust license plate.
2 (2) Paying the fees under section 4 of this chapter.
3 **Sec. 4. (a) The fees for an Indiana antique car musuem trust**
4 **license plate are as follows:**
5 (1) The appropriate fee under IC 9-29-5-38(a).
6 (2) An annual fee of twenty-five dollars (\$25).
7 (b) The annual fee referred to in subsection (a)(2) shall be
8 collected by the bureau.
9 (c) The annual fee described in subsection (a)(2) and the
10 donations described in subsection (d) shall be deposited in the fund
11 established by section 5 of this chapter.
12 (d) Subject to IC 5-14-3-4(b)(15), the commissioner may
13 receive donations for deposit in the fund established by section 5 of
14 this chapter.
15 **Sec. 5. (a) The Indiana antique car museum trust fund is**
16 **established.**
17 (b) The treasurer of state shall invest the money in the fund
18 not currently needed to meet the obligations of the fund in the same
19 manner as other public trust funds are invested. Interest that
20 accrues from these investments shall be deposited in the fund.
21 (c) The commissioner shall administer the fund. Expenses of
22 administering the fund shall be paid from money in the fund.
23 (d) On June 30 of each year the commissioner shall distribute
24 the money from the fund to the Association of Antique Car
25 Museums of Indiana."
