MR. SPEAKER:

I move that House Bill 1145 be amended to read as follows:

- 1 Page 3, delete lines 19 through 42.
- 2 Page 4, delete lines 1 through 18.
- 3 Page 12, after line 27, insert:
- 4 "SECTION 10. IC 9-18-38 IS ADDED TO THE INDIANA CODE
- 5 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 6 JULY 1, 1998]:
- 7 **Chapter 38. Indiana Retired Armed Forces Member License**
- 8 **Plates**
- 9 **Sec. 1. As used in this chapter, "Indiana retired armed forces**
- 10 **member" means a person:**
- 11 **(1) who:**
- 12 **(A) has served at least twenty (20) years in the United**
- 13 **States Armed Forces or their reserves and qualifies for**
- 14 **a paid retirement; and**
- 15 **(B) presents a valid United States Uniformed Services**
- 16 **Reiree Identification Card or its reserve equivalent.**
- 17 **Sec. 2. (a) The bureau shall issue an Indiana retired armed**
- 18 **forces member license plate. The Indiana retired armed forces**
- 19 **member license plate shall be designed and issued as a special**
- 20 **group recognition license plate under IC 9-18-25.**
- 21 **(b) The bureau shall confer with representatives of armed**
- 22 **forces retiree organizations concerning a design for the license**
- 23 **plate as prescribed under IC 9-18-25-5.**
- 24 **Sec. 3. An Indiana retired armed forces member license plate**
- 25 **designed under IC 9-18-25 must include the following:**
- 26 **(1) A basic design for the plate, with consecutive numbers or**
- 27 **letters, or both, to properly identify the vehicle.**

1 **(2) A background design, an emblem, or colors that**
2 **designate the license plate as an Indiana retired armed forces**
3 **member license plate.**
4 **(3) Other information the bureau considers necessary.**
5 **Sec. 4. A person who is an Indiana retired armed forces**
6 **member and who is eligible to register a vehicle under this title is**
7 **eligible to receive at least one (1) Indiana retired armed forces**
8 **member license plate upon doing the following:**
9 **(1) Completing an application for an Indiana retired armed**
10 **forces member license plate.**
11 **(2) Paying the appropriate fee under section 5 of this**
12 **chapter.**
13 **Sec. 5. The fee for an Indiana retired armed forces member**
14 **license plate is the appropriate fee under IC 9-29-5-38."**
