DIGEST OF HB 1009 (Updated January 16, 1998 4:09 pm - DI 51)

Citations Affected: IC 9-21.

Synopsis: Minors transported in open truck beds. Makes it a Class C infraction to operate a truck while a person less than 18 years of age is in the open bed of the truck. Exceptions are made for parades, certain farm operations, and certain trucks equipped with seat belts.

Effective: July 1, 1998.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1997 General Assembly.

HOUSE BILL No. 1009

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 9-21-8-54 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 1998]: **Sec. 54. (a) An individual may not operate a truck on a
4 public highway while another individual, who is less than eighteen
5 (18) years of age, is in the open bed of the truck.**
6 **(b) Subsection (a) does not apply to an individual operating a
7 truck:**
8 **(1) in a parade;**
9 **(2) in connection with an agricultural activity; or**
10 **(3) in which all persons less than eighteen (18) years of age
11 who are in the open bed of the truck are:**
12 **(A) in attached seats; and**
13 **(B) secured by seat belts.**
