## HOUSE BILL No. 1028

---

A BILL FOR AN ACT to amend the Indiana Code concerning utilities and transportation.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 8-1.5-5-4 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 1998]: Sec. 4. (a) This section  
3 applies to all municipalities except a consolidated city.  
4 (b) If the legislative body of a municipality adopts the provisions of  
5 this chapter by ordinance, a department of storm water management is  
6 established and is controlled by a board of directors.  
7 (c) **Except as provided in subsection (f)**, the board consists of  
8 three (3) directors. The executive of the municipality shall appoint the  
9 directors, not more than two (2) of whom may be of the same political  
10 party.  
11 (d) **Except as provided in subsection (f)**, the legislative body shall  
12 prescribe, by ordinance, the terms of the directors. However, the  
13 legislative body must prescribe the initial terms of the directors so that  
14 they will be staggered.  
15 (e) The executive may remove a director at any time when, in the  
16 judgment of the executive, it is for the best interest of the department.  
17 (f) **If a second class city has a department of public sanitation**

1 under IC 36-9-25, the executive of the city may appoint the  
2 members of the board of sanitary commissioners as the board of  
3 directors of the department of storm water management. The  
4 terms of the members of the board of directors are the same as the  
5 terms of the members of the board of sanitary commissioners  
6 under IC 36-9-25-4.

7 (g) A member of the board of directors of the department of  
8 storm water management appointed under subsection (f) is not  
9 entitled to a salary for serving as a member of the board of  
10 directors of the department of storm water management. However,  
11 a member shall be reimbursed for necessary expenses incurred by  
12 the member in the performance of official duties.
