DIGEST OF HB1065 (Updated January 21, 1998 6:08 pm - DI 87)

Citations Affected: IC 1-1-11-3.

Synopsis: United States flags at half-mast for Veterans' Day. Requires United States flags flown by an agency or office of the state of Indiana on November 7, 8, 9, 10, and 11 to be at half-mast in honor of America's veterans and urges all persons flying flags on these dates to fly the flags at half-mast.

Effective: July 1, 1998.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1997 General Assembly.

HOUSE BILL No. 1065

A BILL FOR AN ACT to amend the Indiana Code concerning general provisions.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 1-1-11-3 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 1998]: **Sec. 3. (a) The general assembly declares that in honor of**
4 **veterans who have died in America's armed conflicts, all United**
5 **States flags flown in Indiana on November 7, 8, 9, 10, and 11 of**
6 **each year should be at half-mast.**

7 (b) Any United States flag flown on November 7, 8, 9, 10, and 11
8 of each year by an agency or office of the state of Indiana shall be
9 flown at half-mast.
