DIGEST OF HB 1168 (Updated January 27, 1998 12:44 pm - DI 93)

**Citations Affected:** IC 9-13.

**Synopsis:** Motor vehicles. Changes the definition of "new motor vehicle" to mean a motor vehicle that either: (1) has not been previously titled and carries a manufacturer's certificate of origin; or (2) has never been transferred to an ultimate purchaser. (Current law requires both conditions to be satisfied.)

**Effective:** July 1, 1998.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 1997 General Assembly.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 9-13-2-111 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 1998]: Sec. 111. "New motor  
3 vehicle" means a motor vehicle:

4 (1) that has not been previously titled under IC 9-17 and carries  
5 a manufacturer's certificate of origin; ~~and~~ **or**

6 (2) that has never been transferred by a manufacturer, distributor,  
7 or dealer to an ultimate purchaser.
