Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. A BILL FOR AN ACT concerning pensions.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1           SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **The pension**  
2 **management oversight commission established by IC 2-5-12 shall**  
3 **study the creation of a pension system for town marshals to be**  
4 **effective July 1, 1999.**  
5           (b) **The pension management oversight commission shall make**  
6 **recommendations to the general assembly before November 2,**  
7 **1998, concerning the results of the study described in subsection**  
8 **(a).**  
9           (c) **This SECTION expires December 31, 1998.**  
10          SECTION 2. **An emergency is declared for this act.**
