# COMMITTEE REPORT

**MR. SPEAKER:**

*Your Committee on Insurance, Corporations and Small Business, to which was referred House Bill 1135, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1            Delete the title and insert the following:
- 2            A BILL FOR AN ACT to amend the Indiana Code concerning
- 3            education.
- 4            Delete everything after the enacting clause and insert the
- 5            following:
- 6            SECTION 1. IC 20-10.1-30 IS ADDED TO THE INDIANA
- 7            CODE AS A NEW CHAPTER TO READ AS FOLLOWS
- 8            [EFFECTIVE JULY 1, 1998]:
- 9            **Chapter 30. Indiana Advisory Council on Secondary School**
- 10          **Athletics**
- 11          **Sec. 1. As used in this chapter, "association" refers to the**
- 12          **Indiana High School Athletic Association.**
- 13          **Sec. 2. As used in this chapter, "council" refers to the Indiana**
- 14          **advisory council on secondary school athletics established by**
- 15          **section 3 of this chapter.**

1           **Sec. 3. The Indiana advisory council on secondary school**  
2 **athletics is established.**

3           **Sec. 4. The council has twenty-one (21) members selected as**  
4 **follows:**

5           **(1) Two (2) members of the house of representatives, not**  
6 **more than one (1) of whom is of the same political party,**  
7 **appointed by the speaker of the house of representatives with**  
8 **the advice of the floor leader of the party opposite the**  
9 **speaker's party.**

10          **(2) Two (2) members of the senate, not more than one (1) of**  
11 **whom is of the same political party, appointed by the**  
12 **president pro tempore of the senate with the advice of the**  
13 **floor leader of the party opposite the party of the president**  
14 **pro tempore.**

15          **(3) Two (2) parents of secondary school athletes, appointed**  
16 **by the superintendent of public instruction.**

17          **(4) Two (2) secondary school teachers who are coaches of**  
18 **secondary school athletics, appointed by the superintendent**  
19 **of public instruction.**

20          **(5) Two (2) members of a governing body of a school**  
21 **corporation, appointed by the Indiana School Board**  
22 **Association.**

23          **(6) The chief executive officer or the chief executive officer's**  
24 **designee of the following organizations:**

25           **(A) The Amateur Softball Association. The person**  
26 **appointed under this subdivision must have knowledge**  
27 **of and experience in softball in Indiana.**

28           **(B) The Indiana Association of the Amateur Athletics**  
29 **Union (AAU). The person appointed under this**  
30 **subdivision must have knowledge of and experience in**  
31 **basketball.**

32           **(C) The Indiana Association of the Athletic Congress.**

33           **(D) The Indiana Golf Association and the Indiana**  
34 **Women's Golf Association. These associations must act**  
35 **jointly to select one (1) member.**

36           **(E) The Indiana State Wrestling Association.**

37           **(F) Indiana Swimming Incorporated.**

38           **(G) The Indiana Youth Soccer Association.**

1           **(H) The United States Gymnastic Federation. The**  
 2           **person appointed under this subdivision must have**  
 3           **knowledge of and experience in gymnastics in Indiana.**

4           **(I) The United States Tennis Association, Indiana**  
 5           **District.**

6           **(J) United States Volleyball, Michiana Region. The**  
 7           **person appointed under this subdivision must have**  
 8           **knowledge of and experience in volleyball in Indiana.**

9           **(K) The Indiana Association of the Amateur Athletics**  
 10           **Union (AAU). The person appointed under this**  
 11           **subdivision must have knowledge of and experience in a**  
 12           **sport that is:**

13                   **(i) governed by the association; and**

14                   **(ii) not listed in clauses (A) through (J).**

15           **Sec. 5. (a) A member of the council may not be an employee or**  
 16           **serve on the governing board of the association.**

17                   **(b) A member of the council serves at the pleasure of the**  
 18                   **member's appointing authority.**

19                   **(c) An appointment to the council is for a four (4) year term.**  
 20           **However, a person who is a member of the council because the**  
 21           **person holds an elected or appointed position ceases to be a**  
 22           **member of the council if the person ceases to hold the position that**  
 23           **qualified the person for membership on the council.**

24                   **(d) A member whose term expires may be appointed for**  
 25                   **subsequent term.**

26                   **(e) A member of the council may not receive per diem or**  
 27                   **compensation for service on the council.**

28           **Sec. 6. (a) The members of the council shall elect a chairman**  
 29           **and vice chairman by majority vote of the entire membership.**

30                   **(b) A majority vote of the entire membership is required for**  
 31                   **the council to act.**

32           **Sec. 7. The council shall do the following:**

33                   **(1) Meet with the board of directors of the association and**  
 34                   **advise the board of directors of the effect of the association's**  
 35                   **rules on participation in the sports represented by the**  
 36                   **council.**

37                   **(2) Recommend to the association changes in the**  
 38                   **association's rules.**

1           **(3) Recommend to the association appropriate ways to honor**  
2           **all athletes and teams that participate in events under the**  
3           **auspices of the association.**

4           **(4) Make recommendations to the association that the**  
5           **council determines are in the best interests of secondary**  
6           **school athletes and athletics in Indiana.**

7           **Sec. 8. A school that is in a school corporation may not be a**  
8           **member of or pay money to the association for any purpose, unless**  
9           **the board of directors of the association does the following:**

10           **(1) Formally considers each recommendation of the council.**

11           **(2) Reports in writing to the council the board's decision on**  
12           **each recommendation of the council.**

13           **(3) Provides meeting facilities and staff assistance for the**  
14           **council.**

15           **(4) Reimburses members of the council for travel or other**  
16           **expenses incurred in participation on the council.**

17           **Sec. 9. (a) Six (6) members of the board of directors of the**  
18           **association shall be elected by junior and senior students attending**  
19           **secondary schools that participate in any association athletic event,**  
20           **according to the following schedule:**

21           **(1) August 1998: two (2) directors for a term of three (3)**  
22           **years.**

23           **(2) August 1999: two (2) directors for a term of three (3)**  
24           **years.**

25           **(3) August 2000: two (2) directors for a term of three (3)**  
26           **years.**

27           **(b) At the expiration of the respective terms under subsection**  
28           **(a), elections shall be made to fill the vacancies for the next three**  
29           **(3) years. Elections to fill unexpired term vacancies are for the**  
30           **unexpired term.**

31           **(c) One (1) of the directors elected under this section shall**  
32           **serve as the chairman of the board of directors of the association.**

1           **Sec. 10. A school that is in a school corporation may not be a**  
2           **member of or pay money to the association for any purpose, unless**  
3           **the board of directors of the association complies with this chapter.**
