## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 35-33-8-3.2.

**Synopsis:** Information on persons released on bail. Requires the clerk of a court to maintain and post information concerning defendants released by the court after depositing cash or securities in an amount not less than 10% of the defendant's bail.

**Effective:** July 1, 1998.

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 35-33-8-3.2 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 1998]: **Sec. 3.2. (a) This section applies when a court releases a  
4 defendant after admitting the defendant to bail by requiring the  
5 defendant to deposit cash or securities with the clerk of the court in  
6 an amount not less than ten percent (10%) of the bail under section  
7 3.1(a)(2) of this chapter.**
- 8 (b) **The clerk of the court shall do the following:**
- 9 (1) **Prepare a record containing information about any**  
10 **defendant, identified by case number only, who is released on**  
11 **a bail bond.**
- 12 (2) **Update the record on a monthly basis.**
- 13 (3) **Post a copy of the record in the office of the clerk.**
- 14 (c) **The record required by subsection (b) must include the**  
15 **following concerning a defendant named in the record:**
- 16 (1) **A description of the offense with which the defendant is**  
17 **charged.**

- 1           **(2) The date of any court appearance scheduled in the matter**
- 2           **that was previously unattended by the defendant.**
- 3           **(3) A statement as to whether a warrant has been issued for the**
- 4           **defendant's arrest for failure to appear under the terms of the**
- 5           **defendant's release on bail.**
- 6           **(4) A statement as to whether the defendant has failed to**
- 7           **comply with conditions of release on bail.**
- 8           **(5) The name of the presiding judge or magistrate who**
- 9           **authorized the release on bail.**
